**INSTRUCTIONS FOR COMPLETION OF APPLICATION FOR UPDATING OF ACCOUNT  
PARTICULARS FORM**

1. Borang ini hendaklah diisi dengan lengkap dalam tiga salinan.  
*This form must be completed in triplicate.*
2. Sila taip atau tulis dengan menggunakan **HURUF BESAR**.  
*Please type or write using **BLOCK LETTERS**.*
3. Setiap kotak hendaklah mengandungi satu huruf sahaja. Sila jarakkan satu kotak di antara setiap perkataan.  
*Each box should contain only one letter. Leave one box between words.*
4. Borang yang telah dilengkapkan mesti disertakan bersama dokumen-dokumen sokongan sekiranya permohonan dibuat oleh orang lain selain dari pendeposit berkenaan.  
*Completed form must be accompanied by supporting documents if the application is initiated by persons other than the depositor.*
5. Setiap borang permohonan penukaran mestilah disertakan dengan dua (2) salinan dokumen-dokumen sokongan yang disahkan benar kecuali penukaran alamat surat-menyurat dan nombor telefon.  
*Each completed application form must be accompanied by two (2) certified copies of relevant supporting documents, except for changes in correspondence address and telephone number.*

*For individual depositors apart from armed forces/police personnel, use the address as per NRIC and unexpired JPN 1/9, JPN 1/11 or JPN 1/22.*
  - b) Untuk anggota tentera/polis, sila gunakan alamat kem/pengkalan/stesen masing-masing.  
*For armed forces/police personnel, use the address of their respective camp/base/station.*
  - c) Untuk pendeposit asing, sila gunakan alamat seperti yang tertera pada pasport (jika ada).  
*For foreign depositors, use the address as stated in the passport (if any).*
7. Sekiranya butir-butir di dalam borang berlainan dari dokumen-dokumen sokongan yang disertakan, borang permohonan akan ditolak.  
*If particulars on form differ from supporting documents provided, the application form will be rejected.*
8. Sekiranya meterai syarikat tidak perlu dilekatkan, pelabur-pelabur korporat hendaklah memastikan cop rasmi syarikat dilekatkan.  
*Where affixation of common seal is not required, corporate investors must ensure that they affix the company rubber-stamp.*
9. Borang yang menunjukkan kesan dipadam atau sebarang jenis cecair pemadam boleh mengakibatkan permohonan ditolak.  
*Form defaced by erasure or any kind of correcting fluid may result in the application being rejected.*
10. Sebarang pindaan yang dibuat di atas borang hendaklah mudah dibaca dan ditandatangani oleh pendepositor/penandatangani diberi kuasa oleh pendeposit korporat.  
*Any amendment made on the form must be legible and signed by the depositor/authorised signatory(ies) of the corporate depositor.*
